## 1. FUNCTIONAL DESCRIPTION

This product is meant for professional use in health care, for examination of the patient.

It is designed to be a functional and user-friendly tool for the operator and patient.

# **General description**

IV stand, all-welded steel tubes, 5-legged foot with 100 mm castors.


Available with or without handle, the stand has 4 hooks. The handle is removable.

## 2. OPERATION


# 2.1 Assembly

If the stand is delivered with the hooks non-mounted, un-screw the screw on top of the inner tube. Remove the hooks from under the foot where it is placed during transportation. Mount the hooks on the tube, tighten well.


Un-screw the star knob.



Fold the hinge.



Mount the handle to the IV stand.



Tighten properly.



## **Foot**

If the IV stand is transported un-assembled, place the tube into the foot (image 1-2) and tighten the Allen screws properly (image 3).







## **Hooks**

If the IV stand is transported un-assembled, the hoo is placed underneath the foot. The screw needed to fasten the hook is in its place on top of the tube. Unwind and mount the hook.

If several IV stands are shipped together, the hooks may be shipped separately. Mount as shown above.



## 2.2 Max load



## **Max load**

Pumps: 3 pumps, evenly distributed.

Bags: The tip and the 4 hooks: max 10

kg evenly distributed. 4 kg/single

hook.







#### 3. MAINTENANCE AND CLEANING

#### 3.1 Routine controls

Routine controls is recommended every 6 months, lubricate if needed.

#### Important!

Failure to perform the following routine can cause the patient and/or operator to be exposed to unnecessary risks and the couch may have a reduced life expectancy. Please check all functions and parts on a regular basis.

Check the following:

- Any unusual sounds.
- Castors and castor locking mechanism.

## 3.2 Cleaning

#### Disinfection

If the product needs to be disinfected, use a diluted alcohol solution. Too strong an alcohol solution can have a drying effect and the imitation leather may deteriorate and crack.

#### Chlorine

Chlorine-base solutions are not recommended as a general rule, since it effects products and environment negatively, differently depending on concentration. If chlorine-based solutions are used, always wipe afterwards with damp cloth.
